

# **CYCU Regulations Governing the Recognition of Student Achievement in Creative Competitions and Journal Publications by the School of Design**

Article 1 The Regulations have been established by the School to cultivate the art and design talent at the School. By engaging in the preparation process of preparing for and participating in competitions, the School aims to enhance the standard of students' works on the international stage and the School's overall research capabilities.

Article 2 Students of the School who have participated in a national or international competition, either independently or as part of a team (comprising faculty and students), in the name of the University or with work produced during their time as students, may apply for recognition in accordance with the Regulations upon meeting the following requirements and submitting supporting documents. In the event that the submitted work is a joint creation by more than one individual, please choose one representative to submit the application. Each student may receive recognition for a maximum of two works each year. Applicants shall submit the application form, competition guidelines, and relevant supporting documents for the awarded prize.

- I. Applicants who place in the top three of national creative competitions organized by external awarding bodies (counties, cities, foundations, enterprises, associations, and inter-school organizations) will receive a NT\$1,500 scholarship for each winning work. Applicants who place in fourth place will receive a NT\$750 scholarship for each winning work. Applicants who place in fifth place will receive a NT\$500 scholarship for each winning work.
- II. Applicants who place in the top three of national creative competitions organized by national-level awarding bodies (governments in Taiwan and China) will receive a NT\$3,000 scholarship for each winning work. Applicants who place in fourth place will receive a NT\$1,500 scholarship for each winning work. Applicants who place in fifth place will receive a NT\$1,000 scholarship for each winning work. Applicants who place in sixth

place will receive a NT\$500 scholarship for each winning work.

- III. Applicants who place in the top three of international creative competitions (please provide the total number of participants) organized by international-level awarding bodies will receive a NT\$5,000 scholarship for each winning work. Applicants who place in fourth place will receive a NT\$3,000 scholarship for each winning work. Applicants who place in fifth place will receive a NT\$2,000 scholarship for each winning work. Applicants who place in sixth place will receive a NT\$1,000 scholarship for each winning work.
- IV. International competition winners invited to accept awards in person should first try to obtain subsidies from external sources for their plane tickets and living expenses to the host country. Upon confirmation of full subsidies granted from external sources, the School will not provide any additional funding. In the event that competition winners receive a partial subsidy from external sources, the School may provide funding up to a maximum of NT\$10,000 to cover the shortfall. In the absence of external funding, the School may provide a maximum subsidy of NT\$5,000.

Article 3 Students of the School (excluding doctoral students) who: (1) have had a personal work or (faculty-student) co-authored paper, created during their time as students, reviewed and published by academic journals; (2) have had a personal work or (faculty-student) co-authored paper reviewed and published by academic journals upon submission in the name the student of the School; or (3) have been awarded a research project grant by the National Science and Technology Council (NSTC) upon application in the name of the School, shall be handled in accordance with Article 7 of the Regulations.

Article 4 Application period: Applications will be accepted from May 1st of each year to May 31st of the same year (the deadline shall be extended by one day if it falls on a holiday). Creative works or papers submitted must be the produced between May of the previous year and the end of May of the current year.

Article 5 In the event that a work is completed within the aforementioned timeframe but fails to undergo the annual review, the review process may be postponed to the following year.

Article 6 The Regulations have been formulated and implemented by the College Administrative Meeting. The funding will be sourced from the “Reward Fund for Research/Academia and Industry Collaboration Project.”

Article 7 The amount of the aforementioned relevant awards and subsidies may be adjusted by the College Administrative Meeting based on the actual state of implementation of the current year.

Article 8 The reference table of award funds by level and ranking is as follows:

Article 9 The Regulations have been announced and implemented upon approval by the College Administrative Meeting. The same procedure shall apply to all subsequent amendments.
