Regulations for the Establishment of the Faculty Review Committee of the College of Engineering, Chung Yuan Christian University

Article 1: These regulations are established in accordance with Article 20 of the University Act, Article 21 of the University's Organizational Regulations, and the University's Regulations for the Establishment of Faculty Review Committees.

Article 2: The Faculty Review Committee of the College of Engineering (hereinafter referred to as 'the Committee') reviews the following matters concerning full-time (part-time) faculty members:

1. Faculty appointments, terms of appointment, suspension, dismissal, non-renewal, extension of retirement, and reasons for severance.

2. Faculty promotions and applications for re-evaluation.

3. Faculty evaluations.

4. If decisions made by department faculty review committees regarding suspension, dismissal, or non-renewal are clearly inconsistent with legal regulations or evidently inappropriate, and if there is clear evidence, the Committee may review and change such decisions in accordance with regulations.

5. Qualifications for honorary faculty titles.

6. Matters that must be reviewed by the Committee according to legal regulations. After approval by the Committee, these matters are submitted to the University Faculty Review Committee for further review.

Article 3: The Committee consists of seven to nine professors. The Dean is an ex-officio member and serves as the convener. Other members are elected by the College Affairs Meeting for a term of one year.

Article 4: Meetings of the Committee require a quorum of two-thirds of all members. Decisions require the approval of two-thirds (inclusive) of attending members. Voting is conducted anonymously. Members who are parties to matters under review must recuse themselves.

Article 5: The professional academic ability of applicants' works or creations should be respected during professional reviews. Anonymous voting should not result in contrary decisions.

Article 6: The Committee meets at least once per semester and may hold extraordinary meetings as necessary. Relevant personnel may be invited to attend meetings as needed. The proxy for ex-officio members must hold an equivalent faculty qualification. Members who are absent without reason three times will have their membership revoked. Vacancies are filled according to original regulations.

Article 7: Matters concerning faculty appointments, promotion review regulations, reevaluation application guidelines, faculty evaluation regulations, and handling guidelines for plagiarism in faculty works are handled in accordance with the University's Regulations for the Establishment of Faculty Review Committees.

Article 8: Full-time research personnel and professional technical personnel engaged in teaching are subject to these regulations.

Article 9: These regulations are implemented after approval by the College Affairs Meeting and subsequent approval by the University Faculty Review Committee.
